- 4.3 Aquatera Utilities Rate Changes 2022/2023

Aquatera Utilities is a municipal corporation owned entirely by the City of Grande Prairie, County of Grande Prairie No. 1, the Town of Sexsmith, and the Town of Wembley.

Ms. Lora Brenna, COO, Mr. Jeff Pieper, CFO, and Vaughn Bend, CEO, were all present to discuss Aquatera's rate changes. Discussion centered around the following points:

- In 2022, customers will see a water rate increase of 5.0 per cent and a wastewater rate increase of 10.0 per cent.
- In 2023, customers will see a water rate increase of 5.0 per cent and a wastewater rate increase of 10.0 per cent.
- Costs associated with the necessary capital projects and upgrades are the largest determinant of how future rates are structured.
- Rates are determined through a full-cost recovery rate model that measures the true cost of operating Aquatera which is funded equitably by both current and future customers.
