  - a. Third Quarter Statistics discussed comparisons with last year statistics. The number of motor vehicles being stolen has increased by 350% and offensive weapons up by 600%.

The main purpose of this Program is to keep younger offenders out of the courts. Peace River is using this Program and it has been very successful.

This means that they will get two days a month for training on crime prevention with the RCMP assisting as a resource.
  - d. Enhanced Members two more RCMP members will be assigned to Beaverlodge and Sargent Brown will be working on an MOU for the additional RCMP members.

  The GPREB Contract is an agreement between municipalities and the Canadian Real
