 - The Mayor also asked about Bill 41, The Insurance Amendment Act, which was passed last Fall. Consumers should see some reduction in their auto insurance but it was suggested to shop around.
 - Update on covid 19 75% of Province should have their first shots by mid-June and focus is economic recovery.
