7.1 Bylaw 733-C: Amendment to Land Use Bylaw 733

A By-Law to amend Town of Wembley Land Use By-Law No. 733.

- a. Addition of Child Care Facility be added as Discretionary Use to Primary Commercial (CP) and Public Service (PS).
- b. Addition of a Direct Control (DC) District site-specific area. The purpose of this Direct Control District is to allow for the development of manufactured homes on an interim basis until such time as the subject lands are developed for commercial use. This District shall apply to Lots 4-8, Block 4, Plan 3255CL.
- c. To delete and replace Communication Towers and Antenna Systems content. The purpose of this section is to establish a procedure and recommended standards where a telecommunication carrier is required to consult with the Town for the siting of a new antenna system, or alteration of an existing system, that is regulated by Industry Canada.
